One Semester Options: Available for Spring and Autumn

Option A: Flexible Study Abroad Semesters at Undergraduate and Postgraduate levels:

This option allows students to choose a selection of modules from all DBS programmes offered at both Bachelor and Masters level. Subject areas include: Accounting and Finance, Business and Management, Information Technology and Computing, Law, Marketing and Event Management, Psychology and Social Sciences. Students typically take 30 ECTS credits per semester

Option B: QQI Certificate Programmes:

 Certificate in Global Business (30 ECTS) this programme is a level 7 qualification and designed to provide learners with the knowledge and skills in the core areas of Global Business.
